Eligibility Criteria

1. Valid Registration for Recycler/Re-Processors of E-waste with Central Pollution Control Board / State Pollution Control Board in terms of Ministry of forest notification number S.O 1035(E) Dated 12th May 2011. **A copy the certificate (An Authorized letter issued by concerned State Pollution Control Board for Recycler / Re-processor of E-waste) is must to submit with bid as supportive document.**

General Terms & Condition

1. The auction bid will start from minimum condemnation cost of equipment.
2. The bidder may inspect the items on a pre-determined date and satisfy themselves about the items they are bidding for.
3. The items shall be sold to the highest bidder: Tax will be extra, as applicable.
4. No items, once disposed to the successful bidder, shall be taken back by KV No. 1, AFS, Agra, on any condition whatsoever.
5. Successful bidder will be required to deposit Rs.10000/- on the spot and the balance amount within 03 working days after confirmation.
6. The successful bidder has to make full balance payment in the form of Cheque/demand draft in favour of VVN KV No 1 AFS Agra within three (03) days after confirmation, failing which legal action will be taken against the bidder.
7. The successful bidder shall be required to lift all the items from the disposal site to his premises within three (03) days after the payment of balance amount.
